## SPECIAL SESSION PROPOSALS

Special Session **proposals** must contain the following information:

- Title of the proposed Special Session;
  - Names, affiliations, and contact information of the session organizers;
  - Brief biographies of the session organizers;
  - Brief description of the proposed session with a list of the related topics.
- Special Session **proposals** must contain the following information:

Papers submitted to special sessions will undergo the same review process as regular papers, where the Special Session Organizers are responsible for organizing the peer-review process. If a Special Session has a low number of accepted papers, these may be combined with other special sessions wherever possible, or moved to the regular track. In case of indication of weakly organized special sessions, the Special Session Chairs will support the organizers with advices.
